Welcome & Introductions	Dan Coulter, Deputy Health Officer- Operations for Cecil County Health Department (CCHD), opened the meeting. A brief overview of the agenda was given and introductions were made.	
Building a Healthier Maryland Presentation,]	 Sarah Linden, Maryland Department of Health, presented on the Building a Healthier Maryland Initiative that includes a State Health Assessment & State Health Improvement Plan. Six major categories of data are being reviewed: demographics (including social determinants of health), health overview (morbidity and mortality data), women's health, behavioral health, violence, and chronic disease. As part of the assessment a community survey is being conducted. There have been about 100 responses from Cecil County residents and the BAHM team requests LHIC members help in pushing out the survey. All LHIC members are asked to complete a Public Health System Assessment for their organization. LHIC representatives are being invited to participate on the steering committee for the SHIP.
