## **Description of services:**

The Cecil County Health Department (CCHD) is seeking proposals from qualified audio-visual contractors to design, construct, and perform all related tasks to replace the audio-visual equipment in the auditorium located at 401 Bow Street, Elkton, Maryland 21921.

The project involves the replacement of outdated audio-visual equipment to enhance the functionality and user experience of the CCHD auditorium. The scope of work includes but is not limited to:

- Designing a state-of-the-art audio-visual system
- Removing existing equipment
- Supplying and installing new equipment
- Configuring and testing the new system
- Providing training for CCHD staff on the new system
- Offering ongoing support and maintenance services

## **Qualifications of Bidders:**

Applicants must meet <u>all</u> the below-listed eligibility criteria to be considered for funding:

To be considered for this project, bidders must meet the following qualifications:

- **Experience:** A minimum of 5 years of experience in designing and installing audiovisual systems, particularly in similar settings (e.g., auditoriums, conference rooms).
- **Certifications:** Relevant industry certifications such as CTS (Certified Technology Specialist), AVIXA (Audiovisual and Integrated Experience Association) certifications, or equivalent.
- **References:** Provide at least three (3) references from previous clients for similar projects completed in the past five (5) years.
- **Financial Stability:** Demonstrate financial stability and the ability to complete the project. This may include providing financial statements or other proof of financial health.
- **Insurance:** Proof of liability insurance and worker's compensation coverage. Minimum insurance requirements will be provided by CCHD.
- **Regulatory Compliance:** Adherence to all local, state, and federal regulations and building codes.

## **Proposal Submission Cover Page**

All proposals must include the Proposal Cover Page included in this RFP. An electronic copy in MS Word format may be obtained by contacting the Procurement Officer.

## **Description of Consultant/Organization**

Provide a background of the offeror, citing information demonstrating the ability to meet the eligibility requirements outlined in the Key Information Summary Page Qualifications of Bidders.

## **Proposal Narrative**

The proposal narrative shall delineate how the offeror will achieve the goals and objectives outlined in Section II.

## **Proposed Timeline**

Vendors must develop a proposed timeline for the completion of the project, detailing key milestones and the estimated duration for each phase of the project. The proposed timeline should ensure the project is completed in an efficient and timely manner, minimizing disruptions to CCHD operations.

## Budget

- Vendors will be reimbursed as a progress payment based on the completion of agreedupon project milestones.
- The contractor must submit a detailed budget proposal outlining expected costs for equipment, labor, and any other expenses.
- Pricing shall be based upon continuous, uninterrupted work during normal business hours (Mon. through Fri. 8 a.m. 5 p.m.).
- Payment terms will be net 30 days from receipt of an approved invoice.

**Insurance Coverage**: Prior to commencing work on this contract, the Contractor shall provide the Department with a Certificate of Insurance for itself and any subcontractor under the agreement covering claims arising from the operations and provided under the contract. These insurance coverages shall include the following, as well as any insurance as necessary and required by the U.S. Longshoreman's and Harbor Worker's Compensation Act, the Federal Employers' Liability Act, and any other applicable statute:

- a. The statutory limit for Worker's Compensation coverage;
- b. Broad Form Comprehensive General Liability Insurance with a minimum bodily injury limit of \$300,000 for each person and \$500,000 aggregate for each.
- c. Professional Liability Insurance with a minimum limit of \$1,000,000 per incident and \$3,000,000 aggregate for each occurrence; and

d. Automobile Liability, if applicable.

All coverage shall be provided by insurance companies licensed to do business in the State of Maryland and shall be endorsed to provide 30 day notice of cancellation or non-renewal to the Department's Procurement Officer. All insurance shall be in an amount and type acceptable to the State of Maryland. Any self-insurance program must be documented including any necessary regulatory approval. The Contractor will name the State of Maryland as an Additional Named Insured on all liability policies (Workers' Compensation excepted).

## Proposal Affidavit

All bidders must complete and submit with their Proposal, the Proposal Affidavit attached hereto. Proposals that do not include the Proposal Affidavit may be considered non-responsive and rejected by the Procurement Officer.

#### Proof of Fiscal Integrity

The Bidder shall provide the most current annual report to stockholders and/or any documentation that indicates corporate and/or other financial resources that will permit the bidder to fulfill the terms of this RFP. This documentation may include but is not limited to, one or all of the following:

- a. Dunn and Bradstreet Ratings
- b. Audited Financial Statements
- c. Line(s) of Credit
- d. Successful financial track record
- e. Adequate Working Capital

#### Legal Action Summary

The Bidder shall provide a Legal Action Summary that includes:

- a. A statement as to whether there are any outstanding legal actions or potential claims against the bidder and a brief description of any such action.
- b. A brief description of any settled or closed legal actions or claims against the bidder over the past five (5) years.
- c. A description of any judgments against the Offeror within the past five (5) years, including the case name, number court, and what the final ruling or determination was from the court.

## PART II – SPECIFIC REQUIREMENTS/DELIVERABLES OF PROPOSED CONTRACT SPECIFICATIONS

#### Vendor requirements:

Offerors must have the capacity to meet the eligibility criteria outlined on the Key Information Summary Page, Qualifications of Bidders.

## **Scope of Services:**

The offeror is tasked with developing a design plan for a comprehensive 3-way divisible video conference center that will feature a sizable LED video wall as the primary display. The main video display is to be 13.8' x 7.8' or larger and must be capable of presenting 4 simultaneous inputs that can be routed from any of the three sections within the large room. This will be achieved through the utilization of AV over IP for video routing, ensuring the HDMI inputs possess the ability to be distributed to any location. Additionally, 2 - 85" displays will be positioned in the two smaller sections, each equipped with a decoder to facilitate the reception of inputs. Below each 85" display, a custom wall plate with HDMI input and audio jacks shall be installed, providing direct input to the room display or transmission to the LED Video wall, or both. Each of the three rooms will incorporate a 10" wall-mounted touchscreen controller to manage functions such as audio controls, inputs, and override for the automatic divisible function. Moreover, sensors will be integrated into the airwalls to detect their status when open. Furthermore, each room will be equipped with a conference microphone panel in the center, complemented by ceiling speakers.

In the fully opened state, the 85" displays will function as confidence displays and overflow to ensure that all attendees can view the presentation. Additionally, four PTZ conferencing cameras will be installed in each room, programmable with presets and equipped with facial recognition for tracking capabilities.

The selected contractor will be responsible for the following tasks:

#### 1. Design and Planning

- Conduct a site survey to assess current conditions and requirements
- Develop a comprehensive design plan for the new audio-visual system
- Present design plans to CCHD for approval

## 2. Equipment Procurement

- Source high-quality audio-visual equipment as per the approved design
- Ensure all equipment meets industry standards and CCHD requirements

## 3. Installation

- Remove existing audio-visual equipment
- Install new audio-visual equipment according to the approved design
- Perform all necessary cabling and wiring
- Integrate the new system with the existing infrastructure
- Installation Notes:
- CCHD shall provide electrical access.

## 4. Cable Testing

• Installed cabling meets the stringent performance requirements defined by the ISO/IEC and ANSI/TIA standards bodies.

## 5. Testing

- Test the new audio-visual system to ensure proper functionality
- Conduct a final inspection with CCHD representatives

## 6. Training and Documentation

- Provide comprehensive training for CCHD staff on operating the new system
- Supply detailed documentation including user manuals and maintenance guides

## 7. Support and Maintenance

- Offer post-installation support for a specified period
- Provide maintenance services as required

- A. The Department of Health reserves the right to cancel this solicitation or reject any or all proposals, in whole or in part, to waive minor irregularities in proposals, or to allow the bidder to correct a minor irregularity if the best interest of the State will be served by doing so (COMAR 21.06.02).
- B. All proposals become the property of the Department of Health. Neither the Department nor the State of Maryland shall be responsible for any expenses incurred by the bidders in preparing or submitting their proposals.
- C. All bidders shall acknowledge the receipt of all amendments, addenda, and changes issued in connection with this solicitation.
- D. Proposals may be modified or withdrawn by written notice received in the office designated in this Solicitation before the time and date set for the opening. If expressly permitted in the invitation for proposals, notification of modification or withdrawal may be made by electronic means only in the manner specified in the invitation for proposals.
- E. 1. A Proposal, request to withdraw a Proposal, or a modification to a Proposal is late if it is not received by the Department at the place and by the date and time specified on page 1 of this Solicitation.
  - 2. A late Proposal, late modification, or late request for withdrawal shall not be considered. Exceptions may be made when a late Proposal is received before contract award, and the Proposal, the modification, or withdrawal would have been timely but for the action or inaction of State personnel directing the procurement activity or their employees. A late modification of a successful Proposal, which makes its terms more favorable to the State, shall be considered at any time it is received and may be accepted.
- F. All bidders must complete and submit with their Proposal the Proposal Affidavit attached hereto as Appendix <u>A.</u>
- G. Unless otherwise specified under PART II of this solicitation, this contract shall be awarded to the responsive and responsible bidder submitting the most favorable proposal..
- H. In the case of tie proposals, the award will be made in accordance with COMAR 21.05.02.14, unless another tiebreaker is defined under Section II of this document.
- I. Bidders should give specific attention to the identification of those portions of their proposal that they deem to be confidential, proprietary information, or trade secrets and provide any justification of why this information should not be disclosed under the Annotated Code of Maryland, §§ 10-611 through 10-630 of the State Government Article. Bidders are advised that, upon request for this information from a third party, the Department is required to make an independent determination as to whether the information may or must be divulged to the party. Bidders are further advised that

proposals will be opened publicly unless specifically stated otherwise in Section II (see COMAR 21.05.02.11 and 21.05.02.17).

- J. Any bidder or other interested person who is aggrieved by the award of the contract resulting from this solicitation may protest that decision. If a protest is made, it shall be in accordance with the procedures set forth at COMAR 21.10.02.03. and 04.
- K. The State reserves the right to make the award by item, group of items, or total Proposal if it is in the best interest of the State to do so, unless the bidder specifies in its Proposal that a partial or progressive award is not acceptable. Note: this may render the Proposal non-responsive.
- L. Although Maryland law does not authorize procuring agencies to favor resident Bidders in awarding procurement contracts, many other states do grant their resident businesses preference over Maryland contractors. Therefore, as described in COMAR 21.05.01.04, a resident business preference will be given if: a responsible Bidder whose headquarters, principal base of operations, or principal site that will primarily provide the services required under this INVITATION FOR PROPOSALS is in another state submits the most advantageous Proposal; the other state gives a preference to its residents through law, policy, or practice; and, the preference to be applied to the contract award herein does not conflict with a Federal law or grant affecting the procurement contract. The preference given shall be identical to the preference that the other state, through law, policy or practice gives to its residents.
