The Cecil County WIC program is seeking to contract with an individual or agency to fill the role of Breastfeeding Program Coordinator. This role will be expected to provide services outlined in the Scope of Services for approximately 12-16 hours per week.

**Qualifications of Bidders:**

Applicants must meet all of the below-listed eligibility criteria to be considered for funding:

- Bachelor’s or Master’s degree in Nutritional Sciences, Community Nutrition, Clinical Nutrition, Dietetics, Public Health Nutrition OR has successfully completed specialized training in lactation management and care. International Board-Certified Lactation Consultant (IBCLC) is preferred.
- Has experience in program management.
- Has expertise in breastfeeding management and promotion and working with breastfeeding women.
- Has one or more of the following skills and experience:
  - Program development skills,
  - Minimum of 1 year experience counseling breastfeeding women preferably for breastfeeding,
  - Community action experience,
  - Participant advocacy experience,
- Education background and experience in the development of educational and training resource materials.
- Bilingual in Spanish preferred

The bidder shall submit one copy of the following with each proposal submission:

**Proposal Affidavit**

All bidders must complete and submit with their Proposal, the Proposal Affidavit (**Appendix A**) attached hereto. Proposals that do not include the Proposal Affidavit may be considered non-responsive and rejected by the Procurement Officer.

**Proof of Fiscal Integrity**

The Bidder shall provide the most current annual report to stockholders and/or any documentation that indicates corporate and/or other financial resources that will permit the bidder to fulfill the terms of this IFB (Invitation For Bid). This documentation may include but is not limited to, one or all of the following:

- a. Dunn and Bradstreet Ratings
- b. Audited Financial Statements
- c. Line(s) of Credit
- d. Successful financial track record
- e. Adequate Working Capital

**Legal Action Summary**

The Bidder shall provide a Legal Action Summary that includes:

- a. A statement as to whether there are any outstanding legal actions or potential claims against the bidder and a brief description of any such action.
- b. A brief description of any settled or closed legal actions or claims against the bidder over the past five (5) years.
- c. A description of any judgments against the Offeror within the past five (5) years, including the case name, number court, and what the final ruling or determination was from the court.

- d. In instances where litigation is ongoing and the bidder has been directed not to disclose information by the court, provide the name of the judge and location of the court.

#### Past State Experience

As part of its offer, each Bidder is to provide a list of all contracts with any entity of the State of Maryland that it is currently performing, or which have been completed within the last 5 years.

The contract will be awarded to the vendor presenting the most appropriate budget and who is deemed to have the most demonstrated education/experience to implement the requested services.

## **PART II – SPECIFIC REQUIREMENTS/DELIVERABLES OF PROPOSED CONTRACT SPECIFICATIONS**

### **Background:**

The Cecil County WIC program provides breastfeeding support and education to new and expecting parents in Cecil County. The Breastfeeding Program promotes breastfeeding and helps families make an informed decision about feeding their baby; Proactively helps families build confidence and support for their breastfeeding goals; Responds to breastfeeding questions or concerns families might have; and makes referrals to other WIC breastfeeding experts if needed. The Cecil County WIC Breastfeeding Program Coordinator provides oversight, guidance, and support to ensure WIC requirements are met and the local program is successful.

### **Vendor requirements:**

Offerors must have the capacity to meet the eligibility criteria outlined on the Key Information Summary Page, Qualifications of Bidders.

### **Scope of Services:**

- Provide 12-16 hours weekly to implement tasks such as:
  - Plans, implements and coordinates breastfeeding activities for Cecil County WIC.
  - Update staff with breastfeeding information.
  - Develop the breastfeeding portion of the annual nutrition and breastfeeding education plan.
  - Educate Cecil WIC staff quarterly on select breastfeeding topics which are included in the annual nutrition and breastfeeding education plan.
  - Attend quarterly Maryland WIC Breastfeeding Coordinator meetings.
  - Supervise the breastfeeding educational information being provided by the Cecil County WIC Peer Counselor
- Use the meeting documentation form (**Appendix B**) to document all meetings, educational supervision, and discussions with Peer Counselors and submit it to the contract monitor within 5 working days of the completed session.
- Coordinator will meet at least quarterly with the contract monitor for the purpose of assessing progress and any issues that may arise, gain a better understanding of general staff needs and protective factors, and ensure that deliverables of the contract are on track to be met
- Submit timesheet/invoices weekly to Contract Monitor.
- Must be able to attend the following required trainings:
  1. Maryland WIC Breastfeeding Peer Counselor Training
  2. Maryland WIC “A Journey Together for WIC Managers” Management Program
  3. Maryland WIC Breastfeeding Training Curriculum (all levels)
  4. Annual breastfeeding continuing education
  5. Local agency, health department (where applicable), and State training programs, as required.

## **Content of Proposals:**

### Narrative Application:

- 1-2 page summary of project plan including:
  - Applicants Name, organization, and contact information
  - Brief description of the applicant's experience in program development and management; breastfeeding counseling and work with breastfeeding women; community outreach and participation in advocacy work.
  - Outline of proposed goals, objectives and implementation in order to fulfill contract requirements.

- Budget Narrative: 1 – 2 page outline of expected expenditures.

The term of this contract shall be for the period of **Contract Start Date - June 30, 2025**, with the option of three (3) one-year renewals. The total compensation to be rendered by the contractor shall not exceed **\$20,000 per contract year**.

### **PART III -- GENERAL SOLICITATION AND PROPOSAL PROVISIONS**

- A. The Department of Health reserves the right to cancel this solicitation or reject any or all proposals, in whole or in part, to waive minor irregularities in proposals, or to allow the bidder to correct a minor irregularity if the best interest of the State will be served by doing so (COMAR 21.06.02).
- B. All proposals become the property of the Department of Health. Neither the Department nor the State of Maryland shall be responsible for any expenses incurred by the bidders in preparing or submitting their proposals.
- C. All bidders shall acknowledge the receipt of all amendments, addenda, and changes issued in connection with this solicitation.
- D. Proposals may be modified or withdrawn by written notice received in the office designated in this Solicitation before the time and date set for the opening. If expressly permitted in the invitation for proposals, notification of modification or withdrawal may be made by electronic means only in the manner specified in the invitation for proposals.
- E.
  - 1. A Proposal, request to withdraw a Proposal, or a modification to a Proposal is late if it is not received by the Department at the place and by the date and time specified on page 1 of this Solicitation.
  - 2. A late Proposal, late modification, or late request for withdrawal shall not be considered. Exceptions may be made when a late Proposal is received before contract award, and the Proposal, the modification, or withdrawal would have been timely but for the action or inaction of State personnel directing the procurement activity or their employees. A late modification of a successful Proposal, which makes its terms more favorable to the State, shall be considered at any time it is received and may be accepted.
- F. All bidders must complete and submit with their Proposal the Proposal Affidavit attached hereto as **Appendix A**.
- G. Unless otherwise specified under PART II of this solicitation, this contract shall be awarded to the responsive and responsible bidder submitting the most favorable proposal.
- H. In the case of tie proposals, the award will be made in accordance with COMAR 21.05.02.14, unless another tie breaker is defined under Section II of this document.
- I. Bidders should give specific attention to the identification of those portions of their proposal that they deem to be confidential, proprietary information, or trade secrets and provide any justification of why this information should not be disclosed under the Annotated Code of Maryland, §§ 10-611 through 10-630 of the State Government Article. Bidders are advised that, upon request for this information from a third party, the Department is required to make an independent determination as to whether the information may or must be divulged to the party. Bidders are further advised that proposals will be opened publicly unless specifically stated otherwise in Section II (see

COMAR 21.05.02.11 and 21.05.02.17).

- J. Any bidder or other interested person who is aggrieved by the award of the contract resulting from this solicitation may protest that decision. If a protest is made, it shall be in accordance with the procedures set forth at COMAR 21.10.02.03. and 04.
- K. The State reserves the right to make the award by item, group of items, or total Proposal if it is in the best interest of the State to do so, unless the bidder specifies in its Proposal that a partial or progressive award is not acceptable. Note: this may render the Proposal non-responsive.
- L. Although Maryland law does not authorize procuring agencies to favor resident Bidders in awarding procurement contracts, many other states do grant their resident businesses preference over Maryland contractors. Therefore, as described in COMAR 21.05.01.04, a resident business preference will be given if: a responsible Bidder whose headquarters, principal base of operations, or principal site that will primarily provide the services required under this INVITATION FOR PROPOSALS is in another state submits the most advantageous Proposal; the other state gives a preference to its residents through law, policy, or practice; and, the preference to be applied to the contract award herein does not conflict with a Federal law or grant affecting the procurement contract. The preference given shall be identical to the preference that the other state, through law, policy or practice gives to its residents.

I. FINANCIAL DISCLOSURE AFFIRMATION

  - (ii) Require an employee to satisfactorily participate in a bona fide drug or alcohol abuse assistance or rehabilitation program; and
- (k) Make a good faith effort to maintain a drug and alcohol free workplace through implementation of §K(2)(a)—(j), above.
- (3) If the business is an individual, the individual shall certify and agree as set forth in §K(4), below, that the individual shall not engage in the unlawful manufacture, distribution, dispensing, possession, or use of drugs or the abuse of drugs or alcohol in the performance of the contract.
- (4) I acknowledge and agree that:
  - (a) The award of the contract is conditional upon compliance with COMAR 21.11.08 and this certification;
  - (b) The violation of the provisions of COMAR 21.11.08 or this certification shall be cause to suspend payments under, or terminate the contract for default under COMAR 21.07.01.11 or 21.07.03.15, as applicable; and
